

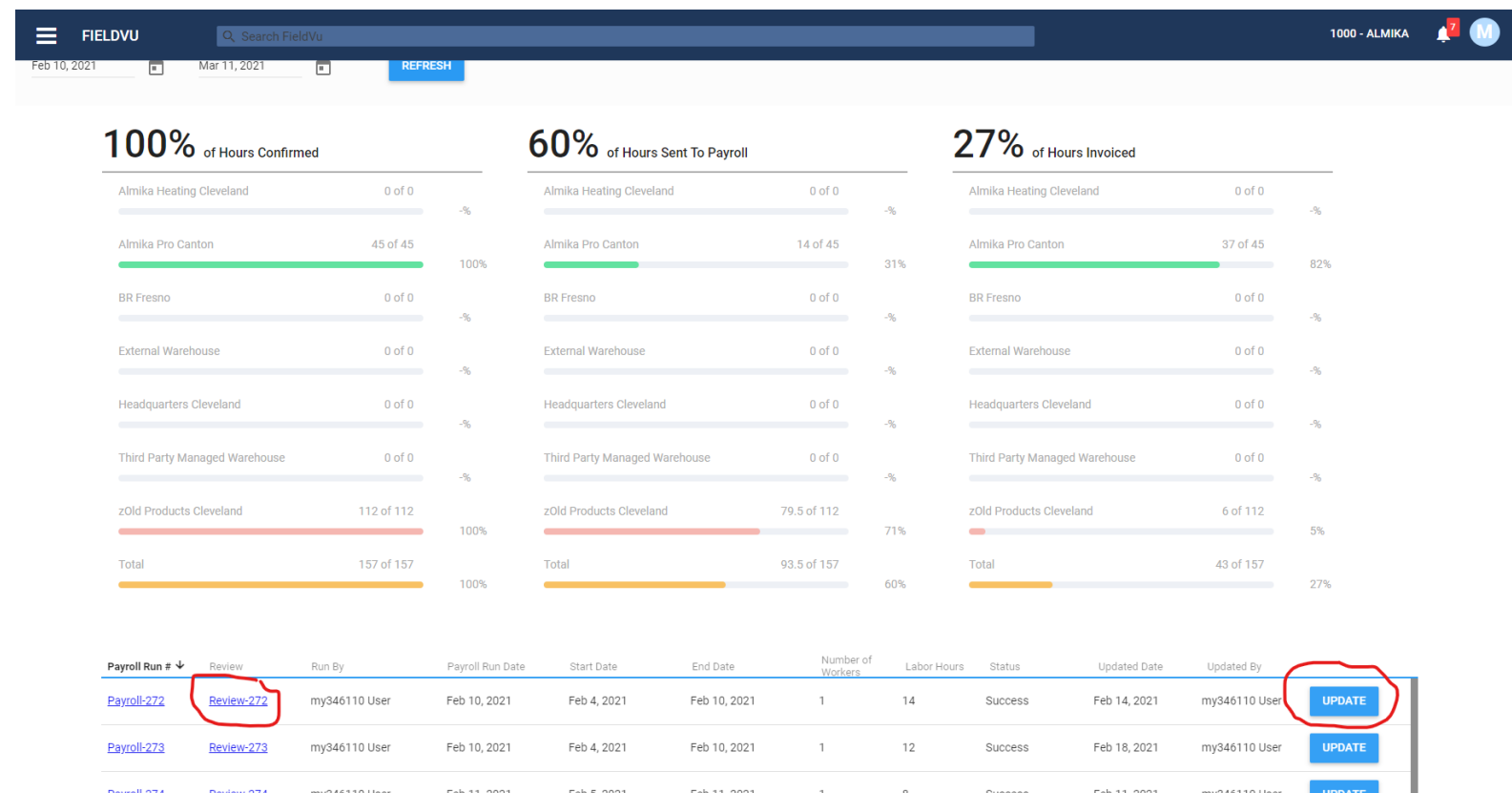

This releases focuses on adding new functionality to Labor Processing, and the ability to choose individual billability on labor lines in Mobile.

Labor Processing - Payroll Review

In FieldVu the hours are approved for invoicing and the hours are also confirmed as correct for pay. However, depending on where the worker works, what union agreement are in place or what the local laws are can determine whether some of those hours are paid at a different rate. Some payroll systems handle this capability, and some do not. With this excel Review and Update workflow we've introduced, you can manage and track these changes in FieldVu to aid in your payroll processing.

How this works is that for each payroll run in FieldVu you now get two files. One for the payroll system, and a review file that is in Excel. This excel file can have charts, reports and validations tailored to your needs. The cool part then is that the Review file can be uploaded into FieldVu to correct the export file to make pushing the data to payroll even simpler.

Labor - Billable and Non-Billable

On Field Tickets and Work Orders, each line was either billable or not. This meant that if you wanted to bill your Labor for Standard Time (ST) and Overtime (OT), but not bill your Per Diem (PD), then you had to create two separate lines for the same worker. This does not scale well and is something we've now fixed. You are able to chose which Hours/Qty is billable or not using this new configuration.
